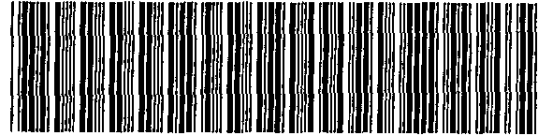

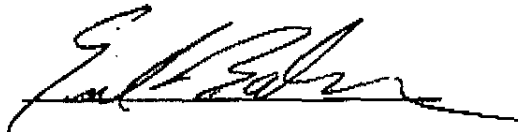
**ARTICLES IV-AMENDMENTS AND BY LAWS**
