#### ARTICLE I

The name of this Corporation shall be SHIRLEY'S PERSONAL CARE SERVICES OF LEHIGH ACRES, INC. .

#### **ARTICLE II**

This Corporation shall exist in perpetuity.

#### ARTICLE III

The general nature of the business to be transacted by this Corporation is to tank acture, purchase or otherwise dispose of, and to invest in, trade in, deal in and with goods, wares, merchandise, real and personal property, foodstuffs, and services of every kind and description, except that it is not to conduct a banking, safe deposit, trust, insurance, surety, express, railroad, canal, telephone, telegraph, or cemetery company, a building and loan association, fraternal benefit society, state fair or exposition.
