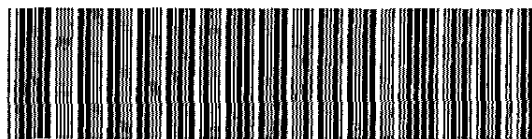

ARTICLE X


