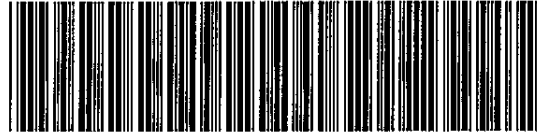

ARTICLES OF INCORPORATION
OF

The undersigned, acting as Incorporator of a Florida Corporation under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation.

ARTICLE I: NAME

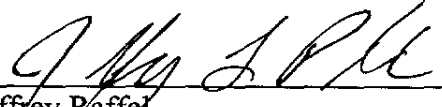
ARTICLE VII: INCORPORATOR

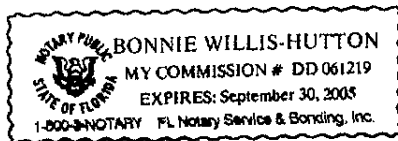
