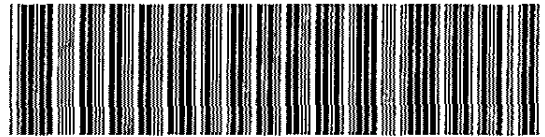

ARTICLES OF INCORPORATION
OF
NEWMAN & SONS WELDING, INC.

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME AND ADDRESS

The name of the corporation is NEWMAN & SONS WELDING, INC. The principal business address of the corporation is 1000 Olive Ave S Lehigh Acres, Florida 33971.

ARTICLE II. NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful activities or businesses permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE III. CAPITAL STRUCTURE
