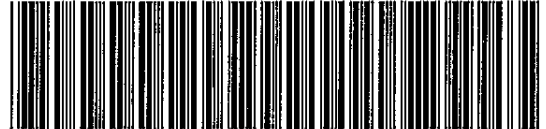

**ARTICLES OF INCORPORATION
OF
JOSEPH W. INVESTMENTS, INC.**

Article I. Name

The name of this corporation is **Joseph W. Investments, Inc.** ("the Corporation").

Article II. Initial Principal and Registered Office and Agent

The street address of the initial principal office of the Corporation is 105 Lucia Avenue, St. Joe Beach, Florida 32456. The mailing address of the initial principal office of the Corporation is Post Office Box 1091, St. Joe Beach, Florida 32456. The initial registered agent is Joseph W. Jordan, Jr.

Article III. Capital Stock

The Corporation is authorized to issue 10,000 shares of \$1.00 per share par value common stock.

Article IV. Preemptive Rights

Upon the sale for cash of any new stock of the Corporation of the same kind, class or series as that which a shareholder already holds, every shareholder shall have the right to purchase his or her *pro rata* share (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.


Article V. Management of Corporation by Shareholders


