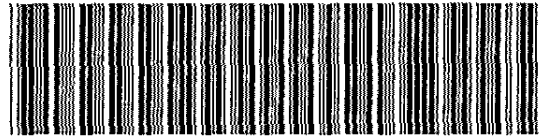

**ARTICLE I - NAME**

The name of this corporation shall be:

The general nature of the business to be transacted by this corporation is:

#### ARTICLE XI - AMENDMENTS



#### ARTICLE XIII - EFFECTIVE DATE

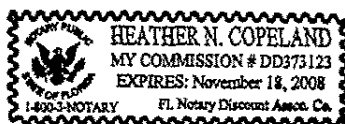


