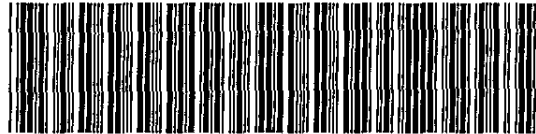

Article I Identification


