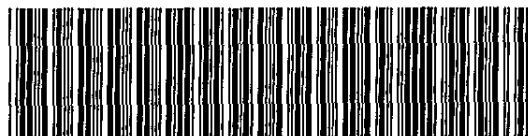

ARTICLE OF INCORPORATION
OF
CODDINGTON & ASSOCIATES, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act hereby adopts the following Articles of Incorporation.

ARTICLE I
NAME

The name of the corporation is: CODDINGTON & ASSOCIATES, INC.
