**ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation under the Florida Law and Florida Corporation Act, adopt the following Articles of Incorporation for such corporation.


#### **ARTICLE XI: INFORMAL ACTION OF DIRECTORS**




