**ARTICLE I - NAME**

The name of the Corporation is Principal Acquisitions, Inc..

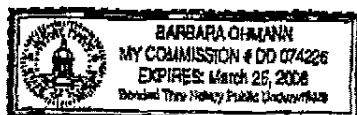
