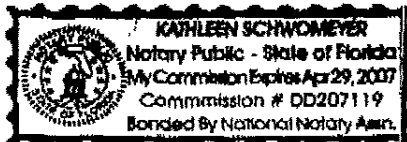


Amendment

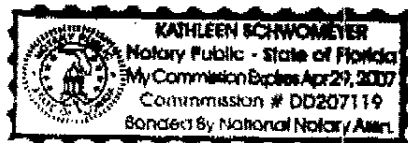
