ARTICLE I - NAME AND BUSINESS ADDRESS

The Corporation shall have a perpetual existence.

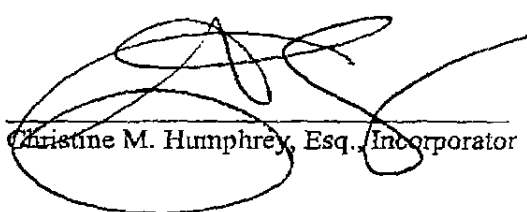
