ARTICLES OF INCORPORATION OF R. S. BRUNO ASSOCIATES, INC.

The undersigned incorporator of these Articles of Incorporation, a natural person competent to contract, hereby presents these Articles for the formation of a for profit corporation under the Business Corporations Act and other laws of the State of Florida.

ARTICLE I

The name of the corporation is R. S. Bruno Associates, Inc.

<u>ARTICLE II</u>

The general nature of the business that will be transacted by the corporation is any legally permissible activity, including personal medical information services.
