These Articles of Incorporation are executed by the undersigned for the purpose of forming a corporation pursuant to the Florida General Corporation Act, as particularly set forth in Chapter 607 of the Florida Statutes.

## ARTICLE 1. NAME.

The name of this corporation shall be named and known as BABY COMFORT RENTALS, INC.

## ARTICLE 2. DURATION.

The corporation shall commence upon the filing of these Articles of Incorporation and shall have perpetual existence thereafter.

# ARTICLE 3. PURPOSE.
