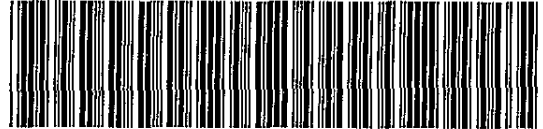

ARTICLE ONE  
NAME

The name of the corporation is REALTORS CONCIERGE SERVICES, INC.

The sole officer of the corporation shall be Robert Swasey, 2015 Jessamine Court, Deltona, Florida 32738, who shall served as President/Treasurer.


ARTICLE ELEVEN

The board of directors reserves the right to amend these Articles of Incorporation from time to time and in any respect as may be desired.


