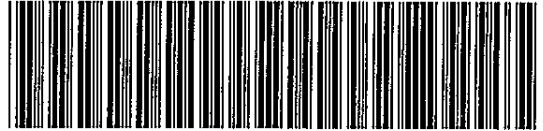

This Corporation may engage or transact in any activity or business permitted under laws of the United States of America, of the State of Florida, or any other state, country, territory, or nation.




