**ARTICLES OF INCORPORATION
OF
ELAINE TURNER, CPA, PA**

The undersigned, acting as incorporator under and by virtue of the laws of the State of Florida, and particularly the Florida General Corporation Act, as provided in Chapter 607, Florida Statutes, and any acts supplementary thereto, adopts the following Articles of Incorporation for such corporation.

ARTICLE I

The name of the corporation shall be: ELAINE TURNER, CPA, PA and its principal office and mailing address shall be:

ARTICLE II

The location of its initial registered office in the State of Florida is 2732 NE 15 Avenue, Wilton Manors, FL 33334, but it shall have the power to establish and maintain branch offices at such cities and towns in the State of Florida and the United States as said corporation may from time to time determine. The name of its initial registered agent at said address is Elaine Turner.

ARTICLE III
