ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF McCANN EAST, INC.

McCANN EAST, INC., a Florida corporation (the "Corporation") whose Articles of Incorporation were originally filed with the Florida Department of State on April 4, 2005 (Florida Division of Corporations Document Number P05000051926), hereby certifies as follows:

1. The Articles of Incorporation of the Corporation are hereby amended by deleting the present form of Article One, as previously may have been amended, in its entirety and by substituting, in lieu thereof, the following:

ARTICLE ONE

The name of the corporation shall be HFC East General Partner, Inc.

2. The foregoing amendment shall become effective as of the close of business on the date these Articles of Amendment are approved by the Florida Department of State and all filing fees then due have been paid, all in accordance with the corporation laws of the State of Florida.

3. The amendment recited in Section 1 above has been duly adopted in accordance with the provisions of Sections 607.0704, 607.0821, 607.1003 and 607.1006, *Florida Statutes*, the shareholders and directors of the Corporation having executed a written statement manifesting their intention that the amendment be adopted.
