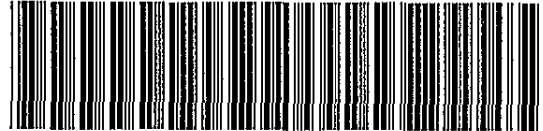

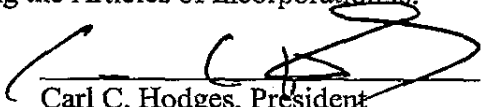
ARTICLES OF INCORPORATION

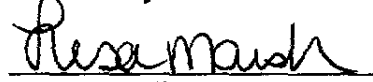
