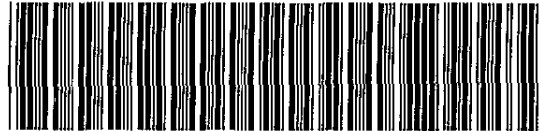

1. **NAME:** The name of this Corporation is *Unicoat Industrial Roofing Corporation*.

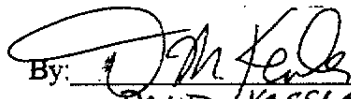
5. **PRINCIPAL OFFICE:** The principal office of this Corporation shall be *3263 81st Court East, Bradenton, FL 34211*.
