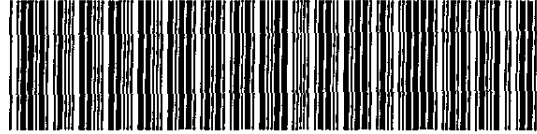

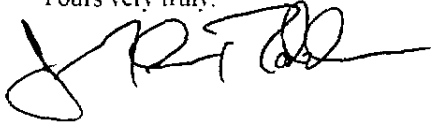

The name of this corporation is: TRAINING CONSULTANTS, INC.
