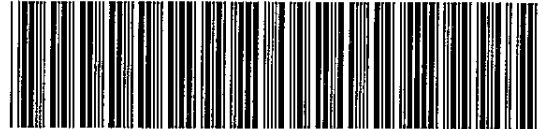

**ARTICLES OF INCORPORATION
OF**

ARTICLE I: CORPORATE NAME

The name of this corporation is **Mark Huller, Inc.**, and its mailing address is, **1069 Sandra Drive, Palm Harbor, FL 34683.**

ARTICLE II: NATURE OF BUSINESS

This corporation may engage in or transact any or all lawful activities or business permitted under the laws of the United States, the state of Florida, or any other state, country, territory or nation.


ARTICLE X: PRE-EMPTIVE RIGHTS
