ARTICLES OF INCORPORATION
OF
LAZARO C. MENENDEZ, P.A.

ARTICLE I

The name of the corporation is LAZARO C. MENENDEZ, P.A., (the "Corporation").

ARTICLE II

The address of the principal office and the mailing address of the Corporation is 1305 West 39th Place, Hialeah, Florida 33012.

ARTICLE III

This Corporation shall have authority to issue One Thousand (1,000) shares of Common Capital Stock having a par value of \$0.01 per share.

ARTICLE IV

The Corporation shall hold a special meeting of shareholders only:
