ARTICLE I

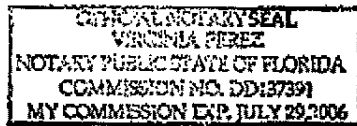

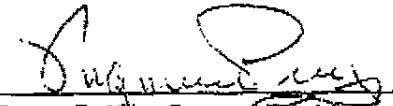

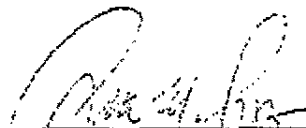
