ARTICLES OF INCORPORATION OF ROYAL YACHT SALES, INC.

The undersigned does hereby act as incorporator in adopting the following Afficies of incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act.

FIRST: The corporate name of the corporation (hereinafter called the "Corporation") is ROYAL YACHT SALES, INC.

SECOND: The street address and mailing address of the principal office of the corporation is 1080 Goodlette Rd., Naples, Florida 34102.

THIRD: The number of shares that the Corporation is authorized to issue is 1,000 shares of Common Stock, no par value.

<u>FOURTH</u>: The street address of the initial registered office of the Corporation in the State of Florida is 1080 Goodlette Rd., Naples, Florida 34102.

The name of the initial registered agent at the said registered office is Alfred J. Teti.

SIXTH: The purpose for which the Corporation is organized is as follows:

SEVENTH: The duration of the Corporation shall be perperual.
