

ARTICLES OF INCORPORATION

OF

ARTICLE I. CORPORATE NAME.

The name of the corporation is Campbell & Sons, Inc.

ARTICLE XIII. INDEMNIFICATION.

The Corporation shall indemnity any officer or director, or any former officer or director, to the full extent permitted by law.
