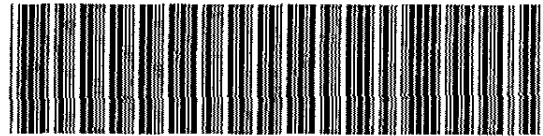

ARTICLE I - NAME

The name of this Corporation is Bishop 2, Inc. and the address is 1348 Valley Pine Circle, Apopka, Florida 32712.

ARTICLE II - TERM OF EXISTENCE

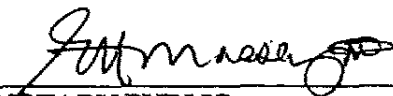
