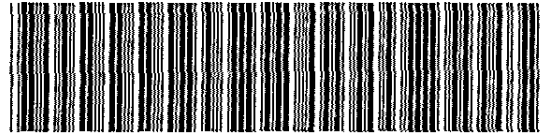

**ARTICLE I
Name**

The name of the corporation is **DAVID M. PRESNICK, P.A.**

**ARTICLE II
Duration**

This corporation shall exist perpetually.

**ARTICLE III


