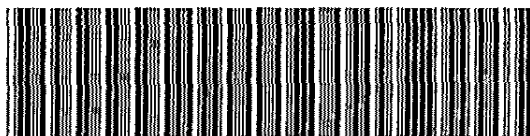

AMENDMENT


