ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of this Corporation is Boca Raton Bridal and Consultants, Inc.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing on April 8, 2005.


ARTICLE XI - BY-LAWS
