Neighborhood Bank Corporation, a corporation organized and existing under the laws of the State of Florida (the "Corporation"), in accordance with the provisions of Section 607.1006 of the Florida Business Corporation Act (the "Act"), does hereby amend its Articles of Incorporation ("Articles") by filing these Articles of Amendment and, in connection therewith,

HEREBY CERTIFIES:

That the name of the Corporation is Neighborhood Bank Corporation.

Pursuant to the provisions of the Act, the first paragraph of Article III of the Articles of Incorporation is hereby amended by deleting the text thereof in its entirety and inserting the following in lieu thereof:

The aggregate number of shares of common stock (referred to in these Articles of Incorporation as "Common Stock") which the Corporation shall have the authority to issue is 125,000,000 shares having a par value of \$.01 per share, of which 115,000,000 shares shall be designated as "Voting Common Stock," and 10,000,000 shares shall be designated as "Nonvoting Common Stock."
