ARTICLE I - NAME

The name of this Corporation is Debbi Keno, Inc.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing on April 11, 2005.

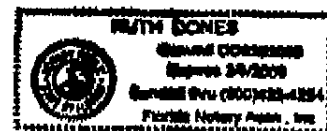
