
The Notice of Dissolution has been issued in error. The above referenced corporation filed the 2006 Annual Report under Jacey's Future Properties, Inc. (P05000054224) on or about July 31, 2006 (copy enclosed). Both corporations – Southern Concrete Coatings, Inc and Jacey's Future Properties, Inc. have the same document number.

In addition to filing the 2006 annual report, a cover letter outlining the events as well as Articles of Amendment were prepared changing the name of the corporation to Southern Concrete Coatings, Inc. from Jacey's Future Properties, Inc (copy enclosed). Please note that the Public Inquiry section under "events" for Southern Concrete Coatings references the name change amendment on 8/02/2006.
