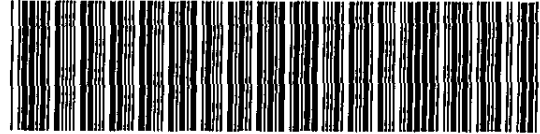

The undersigned incorporator, for the purpose of forming a Florida profit corporation, hereby adopts the following Articles of Incorporation:

Article I

The name of the Corporation shall be JULIAN MASSLER, P.A.

Article III

The purpose for which this corporation is organized is:


Article IX

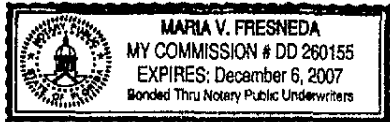
