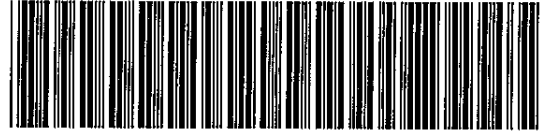

ARTICLE I - NAME

The name of this corporation is Necal Investment, Inc.
