The undersigned, for the purpose of forming a corporation for pecuniary profit under the provisions of Chapters 607 of the Florida Statutes, hereby makes, subscribes, acknowledges, and files the following Articles of Incorporation:

#### ARTICLE I

The name of this corporation is MAID ON D-WAY CLEANING SERVICES, INC.

#### ARTICLE II

#### **Duration and Commencement**

This corporation shall have a perpetual existence, commencing on the date of the filing of these Articles by the Department of State.

#### ARTICLE III

#### <u>Purpose</u>
