#### ATICLES OF INCORORATION

OF

#### U-DESIGN CHARTERS, INC.

The undersigned, being of legal age and competent to contract, for the purposes of organizing a corporation pursuant to the laws of the State of Florida, does hereby adopt the following articles of incorporation, and does hereby agree and certify as follows:

#### ARTICLE I. NAME

The name of the Corporation shall be U-DESIGN CHARTERS, INC.

### ARTICLE II. COMMENCEMENT OF CORPORATE EXISTENCE

The Corporation shall commence corporate existence upon the filing of this Articles with the Secretary of State of Florida, and shall have perpetual existence unless sooner dissolved according to law.

## ARTICLE III. PURPOSES AND GENERAL POWERS

The general purposes of this Corporation shall be the transaction of any and all lawful business. This Corporation shall have all of the powers enumerated in the Florida General Corporation Act, as the same now exists and as hereafter amended, and all such other powers as are permitted by applicable law.

#### ARTICLE IV. CAPITAL STOCK

A. Number and Class of Shares Authorized; Par Value.

The capital stock authorized, the par value thereof, and the class of such stock shall be as follows:

The consideration for all of the above stock shall be payable in cash, property (tangible and intangible), labor or services in lieu of cash, unless otherwise prohibited by law; at a just valuation to be fixed by the Board of Directors of the Corporation.

#### B. Voting Rights.

The Common Stock shall posses and exercise exclusive voting rights and, at all meetings of the Shareholders, each record holder of such stock shall be entitled to one (1) vote for each share held. Shareholders holding Common Stock shall have no cumulative voting rights in any election of directors of the Corporation.

### ATICLE V. PRINCIPLE BUSINESS OFFICE

The principle business office of this corporation shall be located at 5323 Twenty Fifth Street West, Bradenton, Florida 34207.

### ARTICLE VI. MAILING ADDRESS

The mailing address of this corporation shall be: 5323 Twenty Fifth Street West, Bradenton, Florida 34207.

### ARTICLE VII. INITIAL REGISTERED OFFICE AND AGENT

The initial registered office of this corporation shall be located at 5323 Twenty Fifth Street West, Bradenton, Florida 34207, and the initial registered agent of the Corporation at that address shall be Guy S. Davis, II. The Corporation may change its registered agent or the location of its registered office, or both, from time to time without amendment of these Articles of Incorporation.

### ARTICLE VIII. INITIAL BOARD OF DIRECTORS

This Corporation shall have two (2) directors initially. The number of directors may be either increased or diminished from time to time as provided in the bylaws. The names and street addresses of the initial directors of this Corporation are:

### ARTICLE X. BYLAWS

Except as otherwise provided by law, the power to adopt, alter, amend or repeal the bylaws shall be vested in the Board of Directors.

### ARTICLE XI. INDEMNIFICATION

In addition to any rights and duties under applicable law, the Corporation shall indemnify and hold harmless all of its directors, officers, employees and agents, and former directors, officer employees and agents from and against all liabilities and obligations, including attorneys' fees, incurred in connection with any actions taken or failed to be taken by said directors, officers, employees and agents in their capacity as such except for willful misconduct or gross negligence.

### ARTICLE XII. CONFLICTS OF INTEREST

No contract or other transaction between this Corporation and any other corporation, and no act of this Corporation, shall in any way be affected or invalidated by the fact that any of the Directors of this Corporation are precuniarily or otherwise interested in, or are the directors or officers of, such other corporation. Any Director individually, or any firm of which any Director may be a member, may be a party to, or may be pecuniary or otherwise interested in any contract or transaction of this Corporation, provided that the fact that he or such firm is so interested shall be disclosed or shall have been known to the Board of Directors or a majority thereof, and any Director of this Corporation who is also a director or an officer of such other corporation, or who is so interested, may be counted in determining the existence of a quorum at any meeting of the Board of Directors of this Corporation that shall authorization any such contract or transaction with like force and effect as if he were not such a director or officer of such other corporation, or not so interested.

### ARTICLE XII. LIMITED LIABILITY OF SHAREHOLDERS

The private property of the shareholders shall not be subject to payment of the Corporation's debts to any extent.

#### ARTICLE XIV. AMENDMENT

This Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.

The headings or captions of these various articles are inserted for convenience and none of them shall have any force or effect, and the interpretation of the various articles shall not be influenced by any of said headings or captions.
