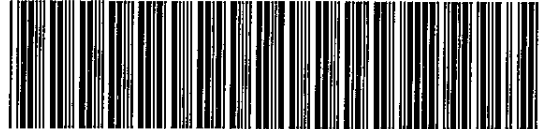

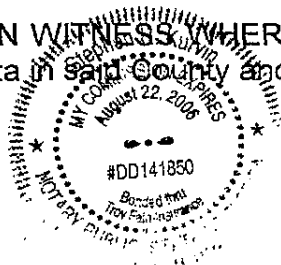


**DESIGNATION OF REGISTERED AGENT**
