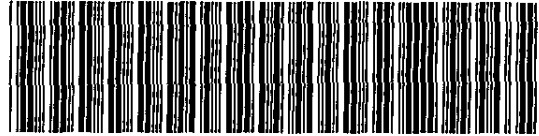

ARTICLE ONE
NAME AND PRINCIPAL ADDRESS

ARTICLE TWO
DURATION

This corporation shall have perpetual existence commencing on the date of filing of these Articles with the Department of State.
