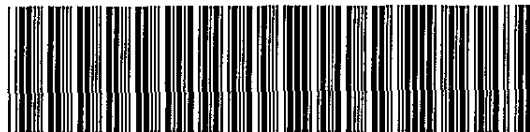

The name of the corporation is PRICE FARMS, INC.
