In compliance with the requirements of F.S. Chapter 607 and 621, the undersigned hereby act as incorporators in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation. STATE OF FLORIDA

ARTICLE I

The name of the Corporation is: Alpha Financial Business, Inc..

ARTICLE II

The commencement of this corporation's existence shall be at the time of the filing of these Articles of Incorporation by the State of Florida, Department of State, Division of Corporations.

This corporation's duration shall be perpetual.

ARTICLE III

ARTICLE IV

The specific purpose for which the Corporation is organized as a mortgage brokerage and and all activities permitted under the laws of Florida and the United States of America.

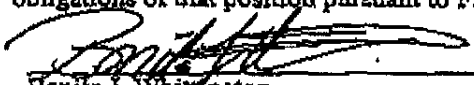
