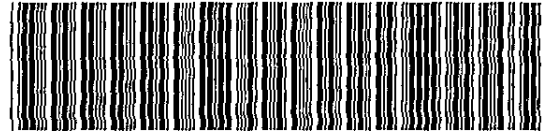

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby associates himself to form a for-profit corporation under the laws of the State of Florida.

ARTICLE I

NAME

The name of the Corporation is DOMINGUEZ GARAGE DOORS, INC.

ARTICLE II

PURPOSES AND POWERS

The corporation's main purpose is to remove, install, and/or maintain garage doors of various types. Furthermore, the corporation may engage in or transact any lawful activity of business which is permitted under the laws of the State of Florida and that can, in the opinion of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the preceding business.

ARTICLE III

CAPITALIZATION

The maximum number of shares of stock this corporation is authorized to have outstanding at any time is FIVE HUNDRED (500) shares of common stock, having a par value of ONE DOLLAR (\$1.00) per share.

ARTICLE IV

INITIAL CAPITAL

The amount of capital with which this corporation will begin business is FIVE HUNDRED AND NO/100 (\$500.00) DOLLARS.

ARTICLE V

PRINCIPAL PLACE OF BUSINESS

The corporation, DOMINGUEZ GARAGE DOORS, INC., shall have its principal place of business at 3124 Raven Road, Orlando, Florida 32803 and its mailing address shall be 3124 Raven Road, Orlando, Florida 32803.

DIRECTORS

The corporation shall have one (1) director initially; the number of Directors may be increased from time to time by the laws adopted by the stockholders, but shall never be less than one (1).


