ARTICLES OF INCORPORATION

OF.

The undersigned subscriber, a natural person competent to contract for the purpose of forming a corporation under the laws of the State of Florida, adopts the following Articles of Incorporation for such corporation.

ARTICLE I

The name of this corporation shall be, New Horizons Screening, Corp.

Its principal office shall be at 1825 4th Lane, Vero Beach, Florida 32962 or at such other place as may be designated, from time to time, by the Board of Directors.

ARTICLE II
