#### CERTIFICATE OF INCORPORATION

OF

#### ARTICLE I

#### NAME AND ADDRESS

The name and principal address of this corporation shall be:

1MAGE ULTRASOUND CORP. 5640 SW 38<sup>TH</sup> ST HOLLYWOOD, FL. 33023

#### ARTICLE II

#### **NATURE OF BUSINESS**

The general nature of the business to be transacted by the corporation is

#### as follows:

To manufacture, purchase or otherwise acquire, and to own and mortgage, pledge, self, assign and transfer or otherwise dispose of, and to invent, trade, deal in and with goods, wares, merchandise and other personal and real property of every class description whatsoever.
