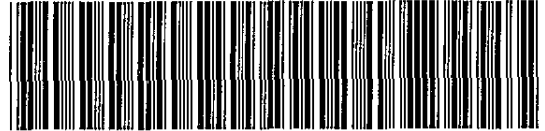

Name


