We, the undersigned, all of whom are of legal age, do hereby associate ourselves for the purpose of becoming a corporation under the laws of the State of Florida authorizing the formation of corporations.

ARTICLE I

NAME

The name of the corporation shall be:

ARTICLE II

GENERAL NATURE OF BUSINESS

The general nature of business and the objects and purposes proposed to be transacted and carried on are to do any and all of the things herein mentioned, as fully and to the same extent as natural persons might or could do, viz:

dispose of shares of capital stock, bonds, mortgages, debentures, notes and other securities, obligations, contracts and evidences of indebtedness of any person, firm, associations and other corporations, whether domestic or foreign, and to exercise in respect of any such shares of stock, bonds and other securities, any and all rights, povers and privileges of individual ownership, including the right to vote thereon, to issue bonds and other obligations, and to secure the same by pledging or mortgaging the whole or any part of the property of the Company, and to sell such bonds and other obligations for proper corporate purposes, and to do any and all acts and things tending to increase the value of the property at any time held by the Company.

d) To acquire, hold, undertake and fully exploit the good will, property rights, franchises and assets of every kind and the liabilities of any person, firm, association or corporation, either wholly or partly, and to pay for the same in cash, stocks or bonds of the Company or otherwise.

e) To borrow money and contract debts when necessary in the purchase or acquisition of real property, personal property, intangible property, business rights or franchises, for additional working capital and for any other object in or about its business or affairs and, without limit as to amount, incur debt and raise, borrow and secure the payment of money in any lawful manner, including the issue and sale or other disposition of bonds, warrants, debentures, obligations, negotiable and transferable instruments and evidences of indebtedness of all kinds, whether secured by mortgage, pledge, deed of trust or otherwise.

f) To acquire, enjoy, utilize and dispose of patents, copyrights and

trademarks, and any license or other rights or interest therein and thercunder in any lawful manner.

g) To conduct business and operations and to have one or more offices and hold, purchase, mortgage, lease, dispose, deal in and convey real and personal property without restrictions in this State and in any other state, territory, possession, and dependency of the United States, the District of Columbia, and in any and all foreign equatries.

b) To purchase or otherwise acquire, become interested in, deal in, invest in, hold, pledge, sell, mortgage, lend money on, exchange or otherwise dispose, or turn on account or realize upon as owner, agent broker, or factor all forms of securities, including stocks, bonds, leases, options, certificates of interest, participation certificates, voting trust certificates evidencing shares of or interest in common law trusts, trusts and trust estates or associations, certificates of trust or beneficial interest in trust, mortgages, contracts and other instruments, securities and rights; to investigate and report with respect to, and to undertake, carry on, aid, assist or participate in the organizational liquidation or reorganization of financial, commercial, mercantile manufacturing, industrial or other business concerns, firms, associations and corporations to institute, participate in or promote commercial, mercantile, financial and industrial enterprises and operations.

i) To engage in and carry on any advertising business in connection with property of any nature, owned, leased or otherwise acquired by this corporation, as principal or agent, with power to let contracts for any advertising, and to make and carry

j) To do any and all things necessary and proper for the accomplishment of the facts enumerated in these Articles of Incorporation and any amendment thereto, and for the protection and benefit of the Corporation; in general, to carry on any lawful business necessary or incidental to the attainment of the objects and protection of the Corporation, whether or not such business is similar in nature. The enumeration of specific powers in this Certificate of Incorporation shall not be deemed to be exclusive. All of said stock shall be payable in cash, equipment, property, real or personal, libor or services in lieu of cash, at a just valuation to be fixed by the

This Corporation reserves the right to amend, alter, change or repeal any provision contained in these Articles of Incorporation in the manner now or hereafter prescribed by statute or set out in the Corporate By-Laws so long as same does not conflict with the Florida Statutes.
