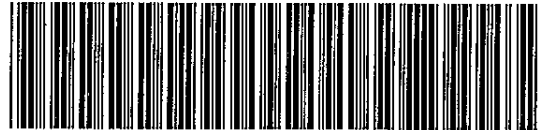

The name of this corporation is YOUR MORTGAGE MART, INC.

Article II - Duration

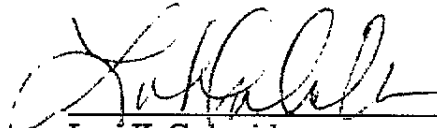

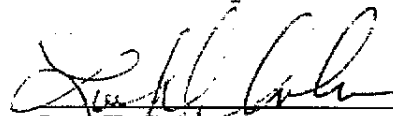
