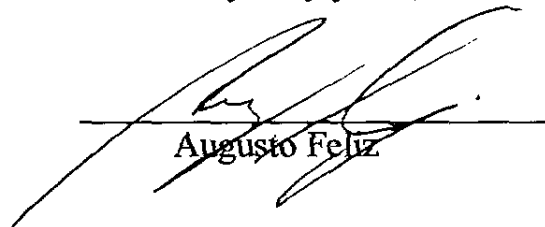

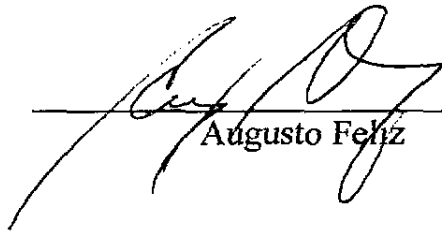
ARTICLE IX: PREEMPTIVE RIGHTS

ARTICLE X: INDEMNIFICATION OF OFFICERS AND DIRECTORS

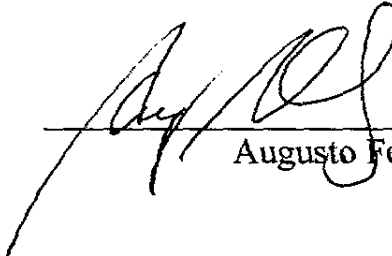
