The undersigned incorporator, JUDD S. JACKSON, a natural person competent to contract, hereby presents these Articles of Incorporation for the formation of a corporation under the provisions of Chapter 607, Florida Statutes.

**ARTICLE I - NAME**

The name of this corporation is JPSP HOLDINGS, INC.

**ARTICLE II - PRINCIPAL OFFICE**

The street address and mailing address of the corporation's principal office is 4703 Seastar Vista, Destin, FL 32541.

**ARTICLE III - PURPOSE**

This corporation is organized for the purpose of transacting any and all lawful business under the laws of the State of Florida and the laws of the United States.


